Today ie 05/09/2023 at around 12:30 PM received a reliable information that some unknown persons were found assembling in Mandop Leikai Areas with an intent to destroy the already vandalised houses/ structures in that area. Immediately, a team of Police party from CCP-PS and WPS-CCP rushed to the spot. On reaching the spot, some unknown persons were found loitering around the areas in a suspicious manner. The unknown persons were rounded up and brought to CCP-PS for further verification. On questioning each of them, they identified themselves as:-

They admitted that they were searching/ dismanteling the structures for scrap, iron rods among the vandalized houses and rubbles.

Hence a suo moto case under FIR No. 2016(09)2023 CCP-PS u/s 427/447/448/34 IPC has been registered against the above mentioned individuals for investigation.
