Sir,

I the undersigned person would like to file a complain regarding my Bolero pick-up Reg. NO. MN06 2457, White in colour, wherein I could not locate nor find my Bolero pick-up 4x4 which was kept at Torbung Bazar Jiten Workshop for repair and Modification on 31st April 2023. Where the information provided by the Mechanics and nearby dwellers stated the vehicles was set on fire during the Arson at Torbung on the 4th May 2023 by an unknown miscreants, in and around 2:40 (pm), further leading to be untraceable and its whereabouts.

However, the reason for the delay of lodging an FIR till date is that, since the owner of the workshop Mr. Jiten could not be contacted and his whereabouts, I, the undersigned made the approach after getting enough information that my Bolero pickup 4x4 was set ablaze by the mob during the Arson on 4th May 2023.
