Sir,

As directed by O.C/TBL-PS, I have visited at the house of one Pheiroijam Indubala @ Indu Devi aged about 42 yrs w/o. Ph. Singhajit Singh of Charangpat Mamang Leikai in c/w an information about forcefully snatching away of money amounting 1,55,000/- by some unknown armed miscreants. In this connection, the said incident took place on 25/11/2023 at around 2:10 pm that some unknown armed miscreants numbering about 5 (five) who came in 2 (two) car i.e. i) i20 Car dark blue in colour B/Regn. No. could not recalled and ii) another Suzuki Swift Car B/Regn. No. MN01A-0413 white in colour entered into the veranda of one Pheiroijam Indubala @ Indu Devi aged about 42 yrs w/o. Ph. Singhajit Singh of Charangpat Mamang Leikai and forcefully took away a sum of Rs. 1,55,000/- along with some documents of Tender Marup.

It is therefore, submitted the above report for taking further necessary legal proceedings against the unknown youths.
