With due respect, the undersigned namely
Memcha aged about 65 yrs resident of Khuga
Meitei Christian Ikhel beg to submit the following
few lines for your kind consideration and
necessary action.

That on 4/05/23 at about 11.30 am some
unknown persons numbering about 300
belonging to Kukli community started attacking
the undersigned along with family members.
Thereafter the Kukli people started destroying
and burning the house of the undersigned
resulting in all the properties of the undersigned
were razed to the ground and all the belongings
and Jewellery were also burned/destroyed
stolen before burning/demolished.

In the above facts and circumstances,
therefore respectfully requested that your good office
may cause the arrest of the misdoers as
belongs to the Kukli community involved in
burning/dismantling/damaging my properties
and injuring and the take up and bring them
as soon as possible for the interest of justice.

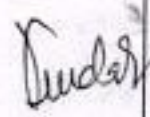

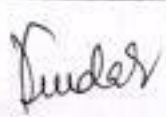
