And my properties net worth around ₹ 10,00,000
Ten lakhs only of rupees has been burnt down and
destroyed by Kuki Army militant.

I therefore requested you to kindly take up
necessary legal action against these criminal and restore to me
And for this Act of kindness, I shall remain ever
grateful to you.
