Subject: Report for some destruction done to my belongings.

Respected Sir,

I, the undersigned beg to report for your kind and necessary action.

1. That, I and my family members are also a part of the victims of the present incident that occurred from 03-05-2023 onwards as present incident causes destruction to my belongings which is a part of my livelihood.
2. That, on 3rd May, 2023 at around 11pm, while I was at my rented residence located at Tuibong HMarveng P.O – C.C Pur, P.S – C.C Pur, District – C.C Pur, Manipur, some unknown armed miscreants i.e suspected as Kuki tribes as a part of the incident destroyed my repairing properties and burned them down worth around Rs. 20 lakhs (Rupees Twenty Lakhs) approximately.
3. The serial no. of my rented residence is 204, Licence No. ADCC/A1(7)/327/(22-D)/2019 – C5, Category : Repairing, Sub-Category : Battery Work these are the description of the said residence which belong to Thangchinkhup Singson. But the belonging which are a part of my livelihood are mine which includes machineries, beds, chairs, tables, almirah, other equipment and all necessary things for living in a place and earning.
4. That, the unknown armed miscreants warned threatened me and my neighbours who are a part of the Manipuris to leave the place permanently and that we will face direct consequences if we return to our Residence again. So, I would like to request to the government of Manipur, to show us some sympathy and helped us, as we are a part of the victims of the deadly incident. I myself have worked hard for several years to provide my children, wife and parents from the said residence where I worked, which provide me a livelihood but all my belongings and machineries, equipments and all my belonging are destroyed. Delay of filling F.I.R is due to the present incident. In view of the facts and circumstances, I shall be grateful if your goodself would kindly initiate appropriate steps for identifying the unknown Miscreants, apprehend them and punish them in accordance with the law. And to kindly see me for the Consequences which I had faced for which I shall always remain grateful to you.


