Churachandpur Police St Manipur at around S. a.m./p.m., while I was at myresistence situated at Churchandpur PO CCpur PS CCpur District CCpur Manipur along with my family members consisting of myself, my husband wife children and other family members, some unknown armed miscreants attacked mythouse, physically assaulted my family members including myself (Rupees fiftin takh and Eigty three Thousand) approximately. That, the unknown miscreants are suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect while firing and physically assaulting my family and destroying my household properties. The said unknown armed miscreants also set on fire and burned down my residential house in CCpur Montop Kikai private vehicles and other household items which are given in the list enclosed along with this report. That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again. Delay of filing an F.I.R is due to displacement and uncertainty of relief camp/place. In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown armed miscreants, apprehended them and bunish them in accordance with law. 


