With due respect, I have the honour to report you for your kind necessary early action.

That, I am the owner, resident and recorded pattadarni of the homestead (semi-pucca building) under Patta No. 446 (New) covered by C.S. Dag No. 3153 measuring an area of 0.039 acres situated at Village No.99-Biyang.

That, on 03-05-2023, at about 7 p.m. my said residential building along with household belongings were all burnt down by some unknown miscreants along with the articles which were kept inside the residential building were also burned down in the said unwanted incident that took place on the same day. I have lost heavily due to the said incident. (List of lost articles are enclosed herewith in a separate sheet). Due to the present unstable situation prevailing in the State I could not report the matter earlier.

In this regard, I would like to request you to kindly take up necessary action against the accused at the earliest.



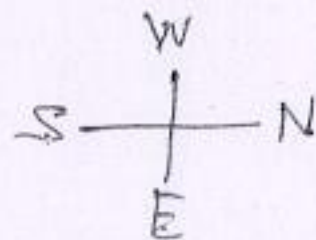
