With due respect, I have the honour to report you for your kind necessary early action.

That, I am the tenant of a rented shop situated at Supermarket, Old Bazar, Churachandpur where I have been running a jewellery shop since the last five years.

That, on 03-05-2023 at about 7 p.m. my said jewellery shop along with the articles which were kept inside the shop were looted and the furnitures were destroyed in the said unwanted incident that took place on the same day. I have lost approximately a sum of Rs. 20,00,000/- (Rupees twenty lakhs) only worth jewellery in the said incident. Due to the present unstable situation prevailing in the State I could not report the matter earlier.

In this regard, I would like to request you to kindly take up necessary action against the accused at the earliest.
