Sir,

With due respect, I have the honour to report you for your kind necessary early action.

That, I am the owner and recorded pattadar of the homestead (semi-pucca building) under Patta No. 446 (New) covered by C.S. Dag No. 3153 measuring an area of 0.039 acres situated at Village No.99-Biyang which I have rented out to a Non-Manipuri since the last 5 years.

That, on 03-05-2023, at about 7 p.m. my said residential building was burned down and destroyed in the said unwanted incident that took place on the same day. I have lost heavily due to the said incident and the said loss of the building structure (G.I. Sheets, bricks etc.) is valued at Rs.20,00,000/- (Rupees twenty lakhs) only. Due to the prevailing unstable situation in the State I could not report the matter earlier.

In this regard, I would like to request you to kindly take up necessary action against the accused at the earliest.

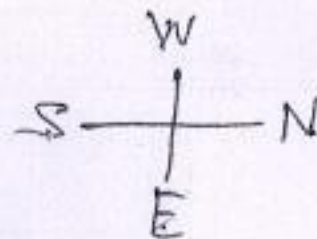

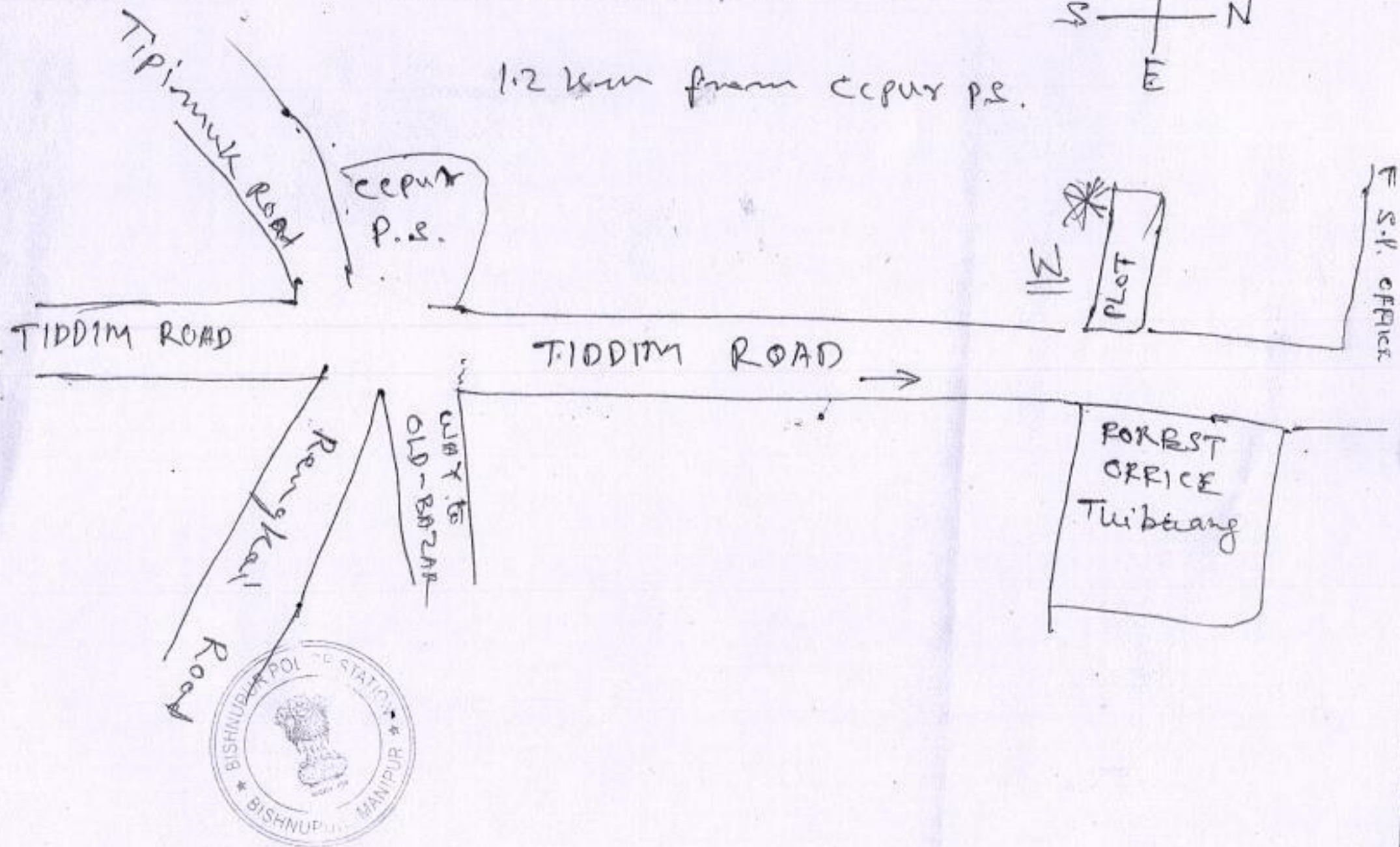
