With due respect, I have the honour to report you for your kind necessary early action.

That, I have a residential homestead land left by my deceased husband at Bijangkhunou, opposite Forest Gate, Churachandpur which is a semi-pucca building under Patta No. 6458 (New) covered by C.S. Dag No. 3153/9202 measuring an area of 0.04 acres situated at Village No.99-Biyang. I also have two shop plots of CI-sheet roofing semi-pucca building standing upon the homestead land under Patta Nos. 648 (New) covered by C.S. Dag No.251 measuring an area of 0.01 acres situated at Village No.96-Khupibung (Old Bazar) and Patta No.586 (New) covered by C.S. Dag No. 4056 measuring area of 0.01 acres situated at Village No.99-Biyang all within the Churachandpur District, Manipur and all have been rented out since the last many years.

That, on 03-05-2023 at about 7 p.m. my said residential building along with household belongings were all burnt down by some unknown miscreants and both the pucca shop structures along with the articles which were kept inside the shop structures were also burned down in the said unwanted incident that took place on the same day. 
