I, the undersigned, have the honour to state that large number of unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki militant groups stormed to all Meitei inhabited areas of Churchandpur Khuga Tampak, Churchandpur District on 4th of May 2023 at around 2.00 am. The said unidentified groups burnt down my houses including valuable items as mentioned below:

1. House (Pukka Building G+2), Vehicles (2 Motor cycles, 1 Car (Maruti 800))
2. Luxurious Furniture (2 Almirahs, 3 Beds, others etc.), Kitchen items (2 gas cylinders, Rice cooker, Oven etc.), Electronics items (TV, Refrigerator, washing machine etc.)
3. Clothing (Phige, Rani, Wangkhei phi, Luxurious items etc.), Jewellery (Necklace, Bangles etc) and Cash, Document such as Bank Passbook, Jamabandi, Aadhaar, voter card, ration card, Pan card, etc.

In that unfortunate incident, property worth more than an approximate amount of Rs.4,000,00,00/- (Forty Lakh) has been lost. After the said unfortunate mob violent, my family members fled our village and presently taking shelter at Peace and Relief camp, Wabagai A/C opened at Wabagai Higher Secondary School, Wabagai.

I, therefore, request you to kindly initiate and take necessary legal action against the accused person(s) involved in the said inhuman acts and heinous crime as per law of the land as early as possible.
