After the said unfortunate violent, my family are fleeing our town and family is taking shelter at Grace Cottage Academy Relief Camp situated at Kakehing Makha Leikai , Kakehing District, Manipur.

It is therefore, prayed that the respected Sir may kindly initiate and take necessary legal action (s) against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons and the persons involved as per law of the land as early as possible.

I shall be grateful for your kind co-operation and necessary actions(s).
