Sir,

I, the undersigned have the honour to state that large numbers of innumerable unidentified group of people belonging to Kuki Community with deadly weapons and sophisticated arms including Kuki Militants groups stormed to all Meitei inhabited areas of Churachandpur Town on 3<sup>rd</sup> May 2023 at @ 5.00 pm. The said unidentified groups vandalized/burnt down my rented house located at Khumujamba Meitei Leikai Churachandpur and looted all valuable items. In that unfortunate incident, I have lost a total amount of Rs. 5,00,000/- Approx. After the said unfortunate violent, my family are fleeing our town and family is taking shelter at Grace Cottage Academy Relief Camp situated at Kakching Makha Leikai, Kakching District, Manipur.

It is therefore, prayed that the respected Sir may kindly initiate and take necessary legal action (s) against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons and the persons involved as per law of the land as early as possible.

I shall be grateful for your kind co-operation and necessary actions(s).
