4. That I am a patient, just undergoing operation about 3 months back in my lungs at Shija Hospital, Langol, Imphal and need regular medical check up, which I am not able to do due the said riot.
5. That after the said riots, my family members are living in a very desperate state and living with the help of aid by friends and relatives and facing acute financial hardship for maintaining my family and taking care of my minor grand children and for treatment of myself.

I, therefore, request you to take up appropriate legal action against the unknown miscreants suspected to be Kuki tribes to compensate my said loss and to give financial assistance to my family to save my family from starvation.

Sir,

Most respectfully, I, the undersigned beg to state the following few lines for your kind perusal and favourable consideration.

1. That I am an inhabitant of Churachnadpur Zou Veng, Khuga Tampak, Meitei Leikai and on 3rd May, 2023 at about 8:00 pm due to the communal riots, some *unknown miscreants suspected to be Kuki tribes burnt down my whole house with all furniture and fittings including beddings, TV, fridges, 407 Truck, Two wheeler, gold ornaments, etc.* The estimated loss of the said fire and arson is/will be about 6 lakhs.
2. That after the said riot as I have no other place to stay, I along with my family members have now taken shelter at a residence of my relative namely Mayengbam Somorjit Singh s/o Late M. Chandramanai Singh of Wabagai Awang Leikai, Kakching District, under Kakching Police Station.
3. That my family members are :-
 - (a) Pukhram Jugindro Singh aged 53 years s/o Late Pukhram Ibotombi Singh (myself).
 - (b) Pukhram Aloftson Khuman aged about 29 years s/o Pukhram Jugindro Singh.
 - (c) Pukhram Ongbi Mayengbam Moris Devi aged about 26 years w/o Pukhram Aloftson Khuman.
 - (d) Pukhram Korounganba Singh aged about 9 years s/o Pukhram Jugindro Singh.
 - (e) Pukhram nongdamba Singh aged about 5 years s/o Pukhram Aloftson Khuman.


