Sir,

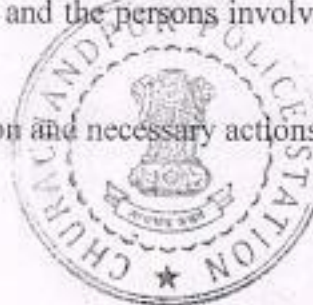
I, the undersigned have the honour to state that large numbers of innumerable unidentified group of people belonging to Kuki Community with deadly weapons and sophisticated arms including Kuki Militants groups stormed to all Meitei inhabited areas of Churachandpur Town at the Midnight of 3rd day of May 2023. The said unidentified groups vandalized/broken down my shop name NG Enterprises Mobile and Watch repairing centre located at Churachandpur New Bazar rented by one Doulian of Churachandpur Rengkai Road and my rented house located at Churachandpur Old Bazar (Zenheng Lamka) rented by one Thangnou of Churachandpur Old Bazar (Zenheng Lamka) and looted all valuable items. In that unfortunate incident, I have lost a total amount of Rs. 1.12 Crore Approx. After the said unfortunate violent, my family are fleeing our town and family is taking shelter at Kakching Higher Secondary School Kakching, Kakching District, Manipur.

It is therefore, prayed that the respected Sir may kindly initiate and take necessary legal action (s) against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons and the persons involved as per law of the land as early as possible.

I shall be grateful for your kind co-operation and necessary actions(s).
