I, the undersigned have the honour to report you that on 3<sup>rd</sup> of May 2023 at around 5-6pm my Hotel located at Old Bazar Zenhang Lamka, Churachandpur was looted and destructed of amount around 2 lakhs by the large number of unidentified people belonging to Kuki community with deadly weapon and sophisticated arms, backed by suspected Kuki militants.

There is a delay in filling the application as my family and I were fled for survival and we are currently taking a shelter in Trade and Expo Centre at Lamboikhongnangkhang.

In this Connection, I humbly request you to kindly initiate and take up necessary legal action(s) against the said militants/groups.

For this act of kindness I shall remain ever grateful to you.




