Subject: Complaint for taking up necessary legal action(s) against suspected Kuki militants for destruction of property including my standing house via looting and burning down.

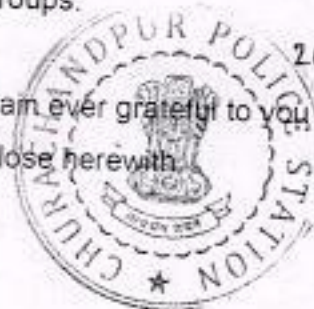
Sir,

I, the undersigned have the honour to report that on 03/05/23 at around 8.00pm all my properties were looted and my house was burnt down by large number of unidentified people belonging to kuki community bearing deadly weapons and sophisticated arms, backed/supported by suspected armed kuki militants who stormed Meitei inhabited areas and village. The said unidentified armed group vandalized/looted/burnt down my house/shop located at Khuga Tampak, Churachandpur and looted all valuable items.

There is delay in filing the application as my family and I were fleeing for survival and we are currently taking shelter at NSCB (Residential School) Lamboi Khongnamakhong.

In this connection, I humbly request you to kindly initiate and take up necessary legal action (s) against the said militants/groups.

For this act of kindness, I shall remain ever grateful to you.


