That on A May at around 9 am/pm, while I was at my residence situated at p.o/F KHUMUZAMBA, MEITEL LEIKAL. p. 0/P.s. Churchardpur Manipur. Along with my family members consisting of myself, my husband/wife, children and others family members, some unknown armed miscreants attacked my house, physically assaulted my family members including with nown armed miscreants attacked thy house, providing the second myself and destroyed household properties worth around myself and destroyed household properties worth around (Rupee Rs 1000000-/ Tex Kakks only (Approx) approximately.

That, the unknown miscreants are suspected to be of the Kuki tribes as they conversed among themselves in the Kuki dialect while firing and physically assaulting my family and destroying my household properties. The said unknown armed miscreants also set on fire and burned down my and other household items which are given in the list enclosed along with this report.

That the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again. Delay of filing a FIR is due to displacement and uncertainty of relief camp/place

In view of the facts and circumstances, I shall be very grateful if your good self would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them accordance with law
