Sir,

I, the undersign have the honour to state that on 3/5/2023 at around 7.00pm while I along with my family members staying at home located at Thengra Leirak, Red Cross Road, P.S.-Churchandpur, some unknown persons numbering about hundred or more belonging to Kuki community attacked to our home as well as the Meitei localities by using knife, gun and stone. They burned down our home and all the belongings were also damaged. Luckily my family members and myself were unharmed with safe and sound.

A separate sheet showing the particulars of all the losses incurred by me is attached along with the present application.

In the above fact and circumstances, it is therefore requesting you to kindly take up legal action against the unknown Kuki people for the interest of the justice.
