Subject: - Report.

Sir,

I have the honour to state that I have been residing very comfortably and peacefully at Churachandpur since the year 1999 by running a shop for spare parts of vehicles there on rent. With the improvement of my shop and with the growth of my children, another shop has been run by dividing into two branches namely Luwang Car Mart exclusively for four wheeler vehicle spare parts in the premises of Jubilee Mawi and another one is Jayso Spare Parts which is only dealt for two and three wheelers spare part in the premises of Ramngai Hmar. Both the shops are located at Lighthouse Lane, Old Bazar, Churachandpur. To facilitate my business and to ensure comfortable livelihood of my family, I purchased four wheelers (five in numbers) and two wheelers (five in numbers) and three separate homestead land at Khugatampak Meitei Leikai, Churachandpur out of which the details for damaged items are hereby furnished in a separate sheet.

Very surprisingly, on 03.05.2023 at around 7.00 pm just after my dinner, the houses nearby my residence at Khugatampak Meitei Leikai were burnt down by some unknown anti social miscreants. As such, all the meiteis staying the locality started running for their lifesos that my family (seven members) narrowly escaped from the violence clashed leaving behind all my assets worth above 5-6 Crore including the items of vehicle spare parts kept for sale in my shop with sale proceeds amounting about Rs. 25,00,000/- (Twenty Five lakh) and my family and myself took shelter at one of my local friend for the time being and at around 2.00 am, we were shifted to Mini Secretariat, Churachandpur with the help of the Indian Army. On the next day at around 10.00 am, my dwelling house (one plus three storeyed pucca building) were burnt down along with all the gold ornaments, household equipments along with sale proceeds etc. and two of my rented shops were also looted by housebreaking. Thereafter, I along with my family, were shifted to Khuman Lampak Relief Camp on 08.05.2023 at about 5.30 pm. Meanwhile, my wife was hospitalized at JNIMS due to collapse. After her discharge from the hospital by midnight, we took shelter at Thangmeiband at one of my elder sister's place (Anju). Thereafter, on 09.05.2023, we went to Moirang Okshongbung Relief camp and we again shifted at Utlou at one of my relative's place on 11.05.2023 till date.

Due to the above facts and circumstances, I could not report my incident occurred on the above date and time which is beyond my control.

Hence, I humbly pray before your goodshelf to take appropriate action in this regard.
