Subject: ***Report on damage/arson/looted properties in respect of the undersigned by armed Kuki miscreants and ATSUM.***

Sir,

With due respect, I, Shri Soibam Thoiba aged about 58 years s/o. Soibam Amureisang Singh, resident of Thengra Leirak, Churachandpur would like to lay the following few lines for your kind consideration and necessary action.

That, on the 3rd of May, 2023, at about 5 pm, some unknown armed persons numbering about thousands belonging to the Kuki community started attacking the undersigned alongwith my family members. Thereafter, they started destroying, looting and burning my house resulting in razing of the whole property into ashes which continues for the next three (3) consecutive days. They even threatened to kill my whole family pointing guns and other weapons against us. We witnessed the destruction/burning/looting of our house and properties which is totally inhuman and deadly. Further, we ran from the house and took shelter at the camp of 36 AR, Headquarter Veng, near 1st IR Bn., Churachandpur.

The whole family is now undergoing a mental trauma from the incident that shocked our minds till date. The details of the properties lost is enclosed as "**Annexure – A**" for necessary action.

On this very day, a rally organized by ATSUM was held and participated by thousands of people belonging to the Kuki & Paite Tribe in Churachandpur District and the mob with criminal intention from the rally incited the incident of torching/burning/destruction/looting of properties, houses and places of worship belonging to the Meitei communities in Churachandpur District and its periphery. The mob were armed deadly weapons and sophisticated guns.

In view of the above facts and circumstances, I therefore respectfully request you to kindly cause the arrest of the miscreants who belong to the ATSUM/Kuki/Paite community involved in the burning/destruction/looting of my property and injuring lives and take up an FIR against them as soon as possible for the interest of justice.


