2.That,on4-05-203 at around \_\_\_\_a.m/p.m., while I was at my family house located at Tuibuong Vong po Churchendour ps Churchendour Dist Churchand Manipur along with my family members consisting of mysely, my husband/wife, children and other family members, some unknown armed miscreants attacked my house, physically assaulted my family members ,including myself and destroyed household properties worth around RJ. 15,000 60-

3. That, the unknown miscreants are suspected to be of the kuki tribe as they conversed among themselves in the kuki dilect while firing and physically assaulting my family and destroying my household properties. The said unknown armed miscreants also set on fire and burned down my residential house,.....private vehicle and other household items which are given in the list enclosed along with this report.

4.That, theunknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again. Delay of filing F.I.R.is due to displacement and uncertainty of relief camp/place. In view of the facts and circumstances, I shall be very grateful if your good self would kindly initiate appropriate steps for identifying the unknown armed miscreants, apprehend them and punish them in accordance with law.
