That, on the 3rd May, 2023 at about 3:00 pm, while I was at Kaprang village, Churachandpur for supplying poultry hens in my Tata Yodha bearing regd. No. MN01AA-4803, there was a solidarity march organised by All Tribal Students Union (ATSUM). After a few minutes, the rally turns into hostile violent activities. Thereafter a mob was formed and in that some unknown armed Kuki Militants in combat dresses holding sophisticated weapons had started attacking on Meitei habitat villages and started damaging and arson activities on fire Meitei houses. And in that, the mob damaged my vehicle and properties. Due to panic and fear of losing live, I ran away from there. The approximate value of the damaged vehicle is Rs. 9, 50,000 (nine takhs and fifty thousand).


