Subject: Report.

Sir,

I have the honour to state that on 03/05/2023 at around 6.00 pm a group of unknown people numbering 100/200 suspected to be members of all Tribal Students Union Manipur (ATSUM) and Kuki militants stormed into our locality with arms and other incriminating weapons. They have torched my 2(two)Paka house, 4(four) Kacha house, 13(thirteen) rented houses and newly constructed (paka building) 2000.00 sq.ft of commercial Gym which is going to open shortly located at Churachandpur Khuga Tampak Meitei Leikai, along with household items, one Maruti Suzuki Swift Desire VDI b/regd.No.MN4P-1807, one Activa and one Heavy Duty 100 XL. They have looted all the said household properties and other valuable articles.

The total approximate value of lost property is around Rs.1,00,000,00/- (one crore only) in present market price.

It is therefore requested kindly to take up necessary legal action against the unknown members of ATSUM and Kuki militants.

I could not report well in time due to the present law & order situation as well as we were displaced and stranded.
