Subject: Report.

Sir,

I have the honour to state that on 04/05/2023 at around 7.30 pm a group of unknown people numbering 100/200 suspected to be members of all Tribal Students Union Manipur (ATSUM) and Kuki militants stormed into our locality with arms and other incriminating weapons. They have torched my 2(two) paka building having 14(fourteen) paka rented rooms located at Khuga Tampak Churachandpur. They have looted all the said household properties and other valuable articles.

The total approximate value of lost property is around Rs.1,00,000,00/- (one crore only) in present market price.

It is therefore requested kindly to take up necessary legal action against the unknown members of ATSUM and Kuki militants.

I could not report well in time due to the present law & order situation as well as we were displaced and stranded.
