Subject : Report.

Sir,

I am to report that on 3rd May 2023, at around 7.00 pm, a huge mob numbering around 200 to 300 unknown people armed with deadly weapons, suspected to be members of ATSUM (All Tribal Students Union, Manipur) and armed kuki militants, stormed into our locality at Thengra Leirak, Chengkonpang, Churachandpur and started ransacking several houses, looting household properties and burning down the houses.

In the said incident, my house was also ransacked and several household properties were looted by the violent and armed mob. Having no other option than to save my life and that of my family members, we ran away leaving behind all our belongings and hide here & there. It is later learnt that my house i.e semi-pacca was burnt to ashes and all the items inside a rented shop was also looted/destroyed. The estimated cost of my house and household properties along with the items inside a rented shop is approximately Rs.43,64,500.00(forty three lakhs sixty four thousand and five hundred). One Alto car (MN02A-3423) & Activa (MN01D-5514) were also burnt.

So, it is requested to kindly take stern legal against the unknown members of ATSUM and armed Kuki militants.

I could not report well in time due to the prevailing law and order situation and myself and my family members were displaced and stranded, taking refuge in the quarter of my brother at Bishnupur Ward No.6 for the last few days.
