Sir,

I have the honour to state that on 03/05/2023 at around 06.30 p.m. a group of people numbering 100/200 suspected to be members of All Tribal Student's Union Manipur (ATSUM) and Kuki militants stormed into our locality with arms and other incriminating weapons. They have torched my House/Sangoi/Vehicle(s)/Cattle/Poultry/Household items/Furniture/Food items/Jewellery items along with other valuable items. And further warned & threatened to leave the village permanently.

The total approximate value of lost property is around Rs.40,30,000/- (Rupees Forty Lakhs Thirty Thousands)appx. in present market value.

It is therefore, requested kindly to take up necessary action against the unknown members of ATSUM and suspected Kuki militants.

I could not report well in time due to the present law & order situation as well as we were displaced and stranded. I am taking sheltered at the Relief Camp opening at TIITET, Bishnupur (B.Ed. College). I have 3(Three) family members.
