They have torched my House/Sangoi/Vehicle(s)/Cattle/Poultry/Household items/Furniture/Food items/Jewellery items along with other valuable items. And further warned & threatened to leave the village permanently.

The total approximate value of lost property is around Rs.11,98,000/- (Rupees Eleven Lakhs Ninety Eight Thousands)appx. in present market value.

It is therefore, requested kindly to take up necessary action against the unknown members of ATSUM and suspected Kuki militants.

I could not report well in time due to the present law & order situation as well as we were displaced and stranded. I am taking sheltered at the Relief Camp opening at TIITET, Bishnupur (B.Ed. College). I have 4(Four) family members.
