Subject: Report.

Sir,

I have the honour to state that on 03/05/2023 at around 6.00 pm a group of unknown people numbering 100/200 suspected to be members of all Tribal Students Union Manipur (ATSUM) and Kuki militants stormed into our locality at Khumujamba Meitei Leikai ,Churachandpur with arms and other incriminating weapons and started ransacking several houses, looting household properties and burning down the houses .

In the said incident, our rented house was also ransacked and several household properties were looted by the violent and armed mob . Having no other option than to save my life and that of my family members, we ran away here and there away from the mob.

It is later learnt that my rented house was burnt to ashes. And also all the items of my rented Mobile shop at located at Churachandpur Old Bazar i.e. RS Mobile Shop were either looted or destroyed. The total approximate value of lost property is around Rs. 20,000,00/- (twenty lakhs only) in present market price.

It is therefore, requested' kindly to take up necessary legal action against the unknown members of ATSUM and Kuki militants.

I could not report well in time due to the present law & order situation as well as we were displaced and stranded. And later arrived to my permanent address.
