With due respect I, Khuraijam Chandrakumar Singh, aged about 42 years, S/o. Late Kh. Damu Singh of Ithai Khunou Makha Leikai, P.O. Moirang, P.S. Kumbi & District Bishnupur, Manipur would like to report you :

1. That, I am the proprietor of a rented Diagnostics centre namely Advanced Diagnostics bearing Registration No. MNHCR/NO/138/CL/15, situated at IB Road CCpur. Govt. High School Gate Opp. CMO Office District Hospital Churachandpur, which is owned by Khaipu Gangte.
2. That, my Diagnostics centre has been seized from 03-05-2023 till date due to the riots occurring all over the Districts of Manipur by the unknown arms miscreants.
3. That, the said unknown armed miscreants warned and threatened me to leave the Diagnostics centre permanently and that I will face dire consequences if I return to my Diagnostics centre again.
4. That, the properties of my said Diagnostics centre is worth around Rs. 90,00,000/- (Rupees Ninety Lacs) approximately and other household items which are given in the list enclosed along with this report.

In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance with law.

I could not report well in time due to prevailing law and order situation.

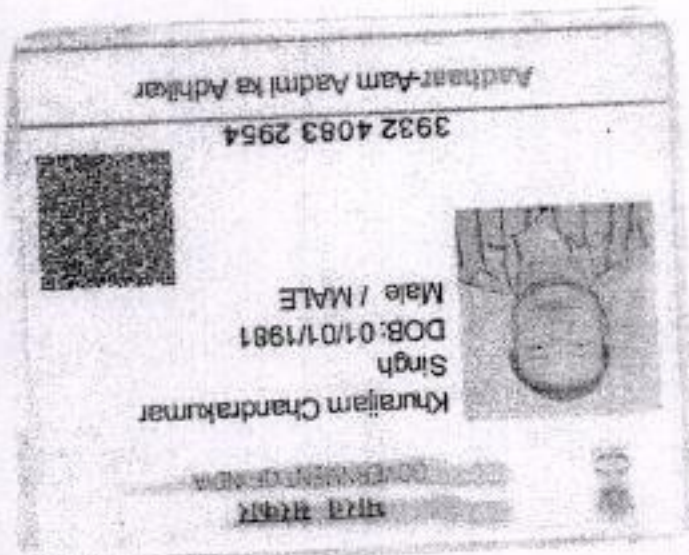
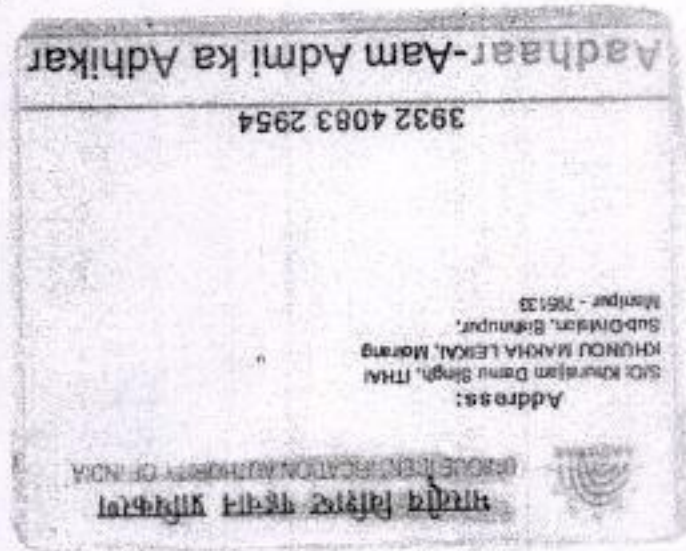
