Subject:- Report on destruction and burning of my house situated at
Khuga Tampak Meitei Leikai, CCpur, under Churachandpur Police
Station.

Sir,

I have the honour to report that on 4th May, 2023 at @ 6:00 am my house including some house hold properties and its apprx. Value is Rs. 60,00,000/- (Sixty Lakhs) in the market price. At the village stated in the subject had been destroyed and subsequently burnt down by a group of unknown armed miscreants. I and my family members left the area running for our lives only with the clothhes we were wearing at the time of the unfortunate incident. All other things includikng cash and ornaments were left behind in the house.

We were provided shelter at a safe place under the escort of armed security personnel.

We have have been further moved to relief cam-p at Khoyol Keithel, Moirang under armed escort. We have further moved to the residence of my brother at Kwashiphai village, Bishnupur District. Hence this report to your good office.

I would, therefore, request you kindly to allow me to join the investigating team at the time of spot enquiry, and thereafter, the detail of the losses may be assessed and reported to you.

I could not report well in time due to the present law & order situation as well as we were displaced and stranded.
