Subject: Report.

Sir,

I am to report that on 10th May, 2023, at around 5:00 p.m., a huge mob numbering around 100 to 200 unknown people armed with deadly weapons, suspected to be members of the ATSUM (All Tribal Students' Union, Manipur) and armed Kuki militants, stormed into our shop located at Zenhang Lamka, Old Bazar, Churachandpur and started ransacking the shop, looting and burning down the shop items.

In the said incident, my shop namely, M/s. Purnima Variety Store was looted by the violent and armed mob. The estimated cost of my shop items lost in the incident is approximately Rs. 25 lakhs. So, it is requested to kindly take stern legal action against the unknown members of ATSUM and armed Kuki militants.

I could not report well in time due to the prevailing law and order situation and myself and my family members were displaced and stranded, taking refuge in the D.C. Office campus, Churachandpur for the last few days.
