Sir,

1 am to report that on 3rd May, 2023, at around 7:50 p.m., a huge mob numbering around 200 to 300 unknown people armed with deadly weapons, suspected to be members of the ATSUM (All Tribal Students' Union, Manipur) and armed Kuki militants, stormed into our shop located at Family Lane Bijang, Churachandpur and started ransacking several shops, looting and burning down the shop items.

In the said incident, my shop namely, M/s. Vicky Spare Parts was also burnt and looted by the violent and armed mob. The estimated cost of my shop items lost in the incident is approximately Rs. 45 lakhs. So, it is requested to kindly take stern legal action against the uknown members of ATSUM and armed Kuki militants.

I could not report well in time due to the prevailing law and order situation and myself and my family members were displaced and stranded, taking refuge in the D.C. Office campus, Churachandpur for the last few days.
