Subject: Report.

Sir,

I am to report that on 4th May, 2023, at around 2:30 p.m., a huge mob numbering around 200 to 300 unknown people armed with deadly weapons, suspected to be members of the ATSUM (All Tribal Students' Union, Manipur) and armed Kuki militants, stormed into our locality at Khuga Tampak Meetei Leikai, Churachandpur and started ransacking several houses, looting household properties and burning down the houses.

In the said incident, my house was also ransacked and several household properties were looted by the violent and armed mob. Having no option than to save my life and that of my family members, we ran away and hid in the open field away from the mob. It is later learnt that my house i.e. one pucca house and one kutcha house and household materials were burnt down to ashes. The estimated cost of my properties lost in the incident is approximately Rs. 50 lakhs. So, it is requested to kindly take stern legal action against the unknown members of ATSUM and armed Kuki militants.

I could not report well in time due to the prevailing law and order situation and myself and my family members were displaced and stranded, taking refuge in the D.C. Office campus, Churachandpur for the last few days.
