





- That, on 99/05/Reas at around ....... a.m./p.m., while I was at home along with my family members consisting of myself, my husband/wife, children and other family house. attacked miscreants unknown armed members. some and myself including family members physically assaulted 14,77,000around Rs. . properties worth household (Rupees Fornton lakes a) Seventy veren (Longo) approximately.
- That, the unknown miscreants are suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect while physically assaulting my family and destroying my miscreants armed unknown said properties. household house. residential burned and fire ..... private vehicle and other Achya - 50, Pulser household items which are given in the list enclosed along with this report.
- That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again.

In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance with law.

IAVe, the undersigned have the honour to report you that on 04/05 /RORB at about 7:00 am/pm, a group of unknown persons suspected to be the members of All Tribal Students Union, Manipur (ATSUM) along with KUKI Militants with full arms numbering about 400 to 700 came to my/our locality and burned down my pueca building/katcha house having 5 rooms, out house (Sangei), shop plot located at Khumuyamba Merfet Kerkai PO Churchan District Churachan Manipur with my/our vehicle Achara 407 on bearing Regn. No.

(I could not remember my vehicle registration number/under process for registration) and household properties, valuable documents and thereby amounting to a sum of Rs. 14, 177,000 (Rupees Fourteen lakks and Green Javana Rayana) approximately altogether.

I could not report in timely to the concerned police station due to the prevailing situation and myself with my family members were displaced and stranded, taking shelter at the Relief Camp, Mangolnganbi College, Ningthoukhong, Manipur.

In this regard, you are, therefore, requested to take legal actions against the persons who acted illegally and punish them under the eye of law as soon as possible.
