

- That, the unknown miscreants are suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect while physically assaulting my family and destroying my unknown said The properties. house. residential household down burned private vehicle and other fire household items which are given in the list enclosed along with this report.
- That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again.

In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance with law.

D.D. . am/pm, a group of unknown persons suspected to be the members of All Tribal Students Union, Manipur (ATSUM) along with KUKI Militants with full arms numbering about 400 to 700 came to my/our locality and burned down my pucca building/katcha house having rooms, out house (Sangoi), shop plot Salkof Kanen Veng Po churachongen Ps churachandpus Unwachoudour Manipur with my/our vehicle Ashira SG bearing Regn. No. M.H.02.B.2763(I-could not remember my vehicle registration

number/under process for registration) and household properties, valuable documents and thereby amounting to a sum of Rs. 12. 10,000 (Rupees Twelve leaken & forty Hous ands.) approximately altogether.

I could not report in timely to the concerned police station due to the prevailing situation and myself with my family members were displaced and stranded, taking shelter at the Relief Camp, Mangolnganbi College, Ningthoukhong, Manipur.

In this regard, you are, therefore, requested to take legal actions against the persons who acted illegally and punish them under the eye of law as soon as possible.
