

- That, on 04/05/2025 at around 7:30 a.m./p.m., while I was at home along with my family members consisting of myself, my husband/wife, children and other family armed miscreants attacked members. some unknown including myself members physically assaulted family 84.99.4001properties Rs. household worth. around (Rupees Fighty form laths Nevetynias there of for home) approximately.
- That, the unknown miscreants are suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect while physically assaulting my family and destroying my armed miscreants said unknown household properties. The residential burned down fire and 016-vehicle, Achive-66 private vehicle and other household items which are given in the list enclosed along with this report.
- That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again.

In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance with law.
