I, the undersigned beg to report for your kind and necessary action.

Manipur

1. That, I and my family members are victims of the present unrest that occurred from 03-05-2023 onwards.

2. That, on 09/05/2023 at around 7:15 a.m./p.m., while I was at home along with my family members consisting of myself, my husband/wife, children and other family members, some unknown armed miscreants attacked my house, physically assaulted my family members including myself and destroyed household properties worth around Rs. 9,99,500/- (Rupees Nine Lakhs Ninety nine Thousand Five hundred and 00/-) approximately.

3. That, the unknown miscreants are suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect while physically assaulting my family and destroying my household properties. The said unknown armed miscreants also set on fire and burned down my residential house, with household articles, clothes, jewelry, books, and others, private vehicle and other household items which are given in the list enclosed along with this report.

4. That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again.

In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance with law.

I/We, the undersigned have the honour to report you that on
09/05/2023 at about 5:15 am/pm, a group of unknown
persons suspected to be the members of All Tribal Students Union, Manipur
(ATSUM) along with KUKI Militants with full arms numbering about 400 to 700
came to my/our locality and burned down my ~~pucca~~ building/katcha house
having 5 rooms, ~~out house~~ (Sangoi), ~~shop~~ plot located at
Zoung Khuga Tampak, Churachandpur P.O. Churachandpur
P.S. Churachandpur District
Churachandpur Manipur with my/our vehicle
bearing Regn. No.

(I could not remember my vehicle registration
number/under process for registration) and household properties, valuable
documents and thereby amounting to a sum of Rs. 9,99,504 Rupees
Nine Lakhs, Ninety nine Thousand and Nine Hundred approximately altogether.

I could not report in timely to the concerned police station due to the
prevailing situation and myself with my family members were displaced and
stranded, taking shelter at the Relief Camp, Mangolganbi College,
Ningthoukhong, Manipur.

In this regard, you are, therefore, requested to take legal actions against
the persons who acted illegally and punish them under the eye of law as soon
as possible.
