- That, on 09/05/9693 at around 7:15 a.m./p.m., while I was at home along with my family members consisting of myself, my husband/wife, children and other family attacked house, armed miscreants members. same unknown myself destroyed including my family members assaulted physically 9,99,500/2 properties worth around household (Rupees Mine lake Minetymian Kansana Fire Aurotan) approximately.
- That, the unknown miscreants are suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect while physically assaulting my family and destroying my armed unknown said The household properties. house. residential burned down my fire and on also state Anna state guitales Surang and are and other private vehicle and other household items which are given in the list enclosed along with this report.
- That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again.

In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance with law.
