I, the undersigned beg to report for your kind and

1. That, I and my family members are victims of the present unrest that occurred from 03-05-2023 onwards.

2. That, on 04/05/23 at around 11:00 a.m./p.m., while I was at my residence situated at Khumiamba Meitei Lekat P.O. Churachandpur P.S. Churachandpur and District Churachandpur Manipur, along with my family members consisting of myself, my husband/wife, children and other family members, some unknown armed miscreants attacked my house, physically assaulted my family members including myself and destroyed household properties worth around Rs. 29,14,500/- + Rs. 7,50,000/- (Rupees Twenty three Lakh fourteen thousand and approximately Five Hundred only).

3. That, the unknown miscreants are suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect while physically assaulting my family and destroying my household properties. The said unknown armed miscreants also set on fire and burned down my residential house, private vehicle and other household items which are given in the list enclosed along with this report.

4. That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again.

In view of the facts and circumstances, I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance with law.

I/We, the undersigned have the honour to report you that on  
4/5/2023 at about 11.50 am/pm, a group of unknown  
persons suspected to be the members of All Tribal Students Union, Manipur  
(ATSUM) along with KUKI Militants with full arms numbering about 400 to 700  
came to my/our locality and burned down my pucca building/katcha house  
having 4 rooms, ~~out house~~ (Sangei), shop plot located at  
*Khunmujamba Meitei dikhai, Churachandpur* P.O. *Churachandpur*  
P.S. *Churachandpur* District  
*Churachandpur* Manipur with my/our vehicle *Jupiter 125*  
*Blue in Colour* bearing Regn. No. ....  
.....(I could not remember my vehicle registration  
number/under process for registration) and household properties, valuable  
documents and thereby amounting to a sum of Rs. *23,14,500* Rupees  
*Twenty three lakhs Fourteen thousand and ...* approximately altogether  
*Five hundred.*

I could not report in timely to the concerned police station due to the  
prevailing situation and myself with my family members were displaced and  
stranded, taking shelter at the Relief Camp, Mangolganbi College,  
Ningthoukhong, Manipur.

In this regard, you are, therefore, requested to take legal actions against  
the persons who acted illegally and punish them under the eye of law as soon  
as possible.
