

i, the undersigned beg to report for your schandpur Police Statioction. Manipur /

That, I and my family members are victims of the present unrest that occurred from 03-05-2023 onwards.

That, on O4/astes at around 11:00 a.m./p.m., while I was at my residence Chumparba Meetie Leekai PO Churachendpar Churachandhur and District ... thurachandhard slong with my family members consisting of myself, my husband/wife, children and other armed miscreants attacked members, some unknown family members including myself and assaulted my household properties worth around Rs. 29, 14, 500/s + R 7,50,000/-Twenty three Lathe fourtien thousand and approximately File Atuadres only

That, the unknown miscreants are suspected to be of the Kuki tribe as they convended among hemselves in the Kuki dialect while physically assaulting my family and destroying my household properties. The said unknown armed miscreants also set on fire and purned down my residential house, ... private vehicle and other household items which are given in the list enclosed along with this

That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again.

in view of the facts and circumstances, I shall be very grateful if your goodself would kithily intuition appropriate steps for identifying the unknown arms miscreants, apprehend them and purish them in accordance with law.

P.S. Churachandpur District Churacampus, Manipur with my/our vehicle Japith 125 Blue-in- Colon bearing Regn. No.

.....(I could not remember my vehicle registration number/under process for registration) and household properties, valuable documents and thereby amounting to a sum of Rs. R3,14,574 Rupees Twenty Three lakes Fourteen Thousand and ) approximately altogether

I could not report in timely to the concerned police station due to the prevailing situation and myself with my family members were displaced and stranded, taking shelter at the Relief Camp, Mangolnganbi College, Ningthoukhong, Manipur,

In this regard, you are, therefore, requested to take legal actions against the persons who acted illegally and punish them under the eye of law as soon as possible.
