Subject: Request for taking up legal action for destruction of Meetei Society Office

Sir,

With due respect, I, the undersigned, on behalf of the people of Churachandpur Meetei community, have the honor to state that the Meetei Society, Churachandpur office building located at Khuga Tampak, Churachandpur was destroyed by armed Kuki people in the communal clash targeting, specifically, minority Meetei people.

The office building along with furniture and all the other items including documents were destroyed on the second day of communal clash, i.e. 4th of May, 2023. at around 11:00 am.

As our primary concern at that time was to save ourselves, some of us flee to army camps and some were rescued by army and state police. As a consequence I couldn't report this matter to the police on time. I am still at a relief camp at the time of filing this report.

I earnestly request you to take up legal and other necessary actions against those miscreants who caused destruction to the office building.
