Sir,

I have the honour to state that on 03-05-2023 at @ 11:10 pm my Bikel Autorickshaw Regd. no. MN01AC2231 having chassis no. MD241A2 X 610022 936 and Engine no. BB2W6D85297 along with sound system and equipments of Khairam Kanto (57) S/O. (L) K. Ibeyanma of Thengbung, W.M.-5 kept inside my autorickshaw were torched by a group of unknown people numbering 10/20 suspected to be the members of All Tribal Student Union Manipur (ATSUM) and Kurai militants which were stormed with arms & other incriminating weapons while we were going to attend a marriage ceremony at Khuga Tampan near a place at Zoueng Loi Hmawbung.

The total approx value of my Autorickshaw is Rs. 2,20,000/- (Two Lakhs twenty thousand) and approx. value of sound system & equipments is Rs. 1,11,200/- (One Lakh eleven thousand & two hundred).

I could not report well in time due to the present law & order situation as well as I was displaced & later rescued.
