Sir,

I have the honour to state that on 3rd May, 2023 at around 6.30 p.m. a group of people numbering 100/200 suspected to be members of All Tribal Students union Manipur (ATSUM) and Kuki militants stormed into our locality with arms and other incriminating weapons. They have torched my house (semi pucca worth Rs. 5 lakhs appx.), furniture & household items (worth Rs. 1.5 lakhs appx.), cattle & poultry (worth Rs. 1.5 lakhs appx) with other valuable items (worth Rs. 50,000/- appx).

The total approximate value of lost property is around 8,50,000/ (Rupees Eight lakhs fifty thosands) in present market.

It is therefore requested kindly to take up necessary action against the unknown members of suspected ATSUM and Kuki militants.

I could not report well in time due to the present law & order situation as well as I am displaced and stranded. I am taking sheltered at the Yening Foundation (De-addiction Center) at Toubul near Imphal main canal. I am alone in my home.
