Sir,

With due respect, I the undersigned would like to state that I am an employee of Jambhoo Navodaya Vidyalaya, Churachandpur District. Due to the recent communal riot/dash between two communities, my vehicle Maruti Omni Van model (white in colour) bearing registration No. MN015 2747 was left stranded inside the Vidyalaya campus along with 2 keys on the said vehicle and the R.C. Book registered in my name.

In the advent, self was displaced and stranded taking refuge inside the 36 Assam Rifles located at Churachandpur. Later from the local staff i.e. MTS of JNV-Churachandpur is learned that the said vehicle was taken away by the unknown miscreants forcibly on 13th May, 2023. The approximate value of the said vehicle worth about 1.5 lak. I could not report well in time, due to the present law and order situation prevailing in the state as well as self was displaced and stranded.

In view of the facts and circumstances, I shall be very grateful if your goodself would kindly take up necessary action against them and to retrieve the said vehicle.
