victim of the present unrest that occurred from 03-05-2023
onwards beg to report for your kind action.

- ① That on 03-05-2023 at around 5:30 PM, while I was at my
rented room (Thengra Meitei Leikai, Churachandpur) some miscreants
attacked my rent room and threatened me to leave the place
(Churachandpur) permanently and that I will face dire
consequences if I return again.
- ② That, later it is learnt, the unknown armed miscreants
also set on fire and burned down my rented room which
includes my furniture, documents, Laptop, clothes, other
items worth around Rs 3,52,000/- (Rupees Three lakh fifty two
thousand) approx. (List of damaged properties enclosed)
- ③ I could not report well in time as I was displaced
& stranded and refuged at STC-BSF Camp Churachandpur.
later arrived to my permanent home.

I shall be grateful if the unknown arm miscreants
are punish in accordance with law.
