Sir,

I, the undersigned beg to report for kind and necessary action.

1. That, I and my family members are victims of the present unrest that occurred from 03/05/2023 onwards.

2. That, on 03/05/2023 at around 08:00 p.m, while I was at my rented home located at Salem Veng, House No.326, New Lamka Churachandpur along with my family members consisting of myself, my husband/ wife, children and other family members, some unknown armed miscreants suspected to be Kuki tribe as they conversed among themselves in the Kuki dialect attacked my house, physically assaulted my family members including myself and destroyed household properties worth around Rs. 23,00,000/- (Twenty-three Lakhs only) approximately.

3. That, the unknown miscreants warned threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again.

In view of the facts and circumstances, I shall be very grateful if your good self would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance.

I could not report well in time due to displaced & stranded and later took sheltered in the relief camp opened at Old DC Office Building Bishnupur.
