With due respect, I the undersigned namely Labuklongbam Okendro Shama
aged about 59 years, resident of Thengra leirak Churachandpur beg to
submit the following few lines for your kind consideration and necessary action.

That on 13/05/23 at about 11:30 PM, some unknown persons numbering about
1000 belongs to kuki community started attacking the undersigned along with
family members. Thereafter the kuki people started destroying and burning the house of
the undersigned were razed to the ground and all the belonging jewelries were also
burned/destroyed/stolen before burning/damaged.

In the said incident..... was badly injured due to pelting of
stones /hacking with knife/shot from firearms toward us by the miscreants.

A separate sheet showing the particular of all the losses incurred by me is attached
along with the present application.

In the above fact and circumstances, it is therefore respectfully requested that your good
self-cause the arrest of the miscreants who belong s to the kuki community involved in the
burning /dismantling /damaging my properties and injuringand
take up a FIR against them as soon as possible of the interest of justice.

Delay of filling a FIR is due to displacement and uncertainty of relief camp/place.




