Subject:- Report.

Sir,

I, the undersigned would like to report that on 03/05/2023 at around 10:00 pm, some unknown persons numbering about 100 persons belonging to Kuki community started attacking the villagers of Khuga Tampak including my family members. Thereafter, the Kuki people started destroying and burning (Arson) my house resulting in all the properties of mine were razed and all the belonging and Jewelleries were also burned, destroyed and stolen before burning. In the above Arson I have loss the following items:-1) Two Pukka Building with 8(eight) rooms and 3(three) rooms respectively, under new patta no. 197/2523 of revenue village no. 3816/5414, 5413/5673 measuring 00.09 acre. 2) One Fesino two wheeler scooty bearing Regn. No. MN06SC-2877. 3) Jewelries (a) Three gold necklace weight 35.64 gm each, (b) Five gold ring weight 11.88 gms each, (c) Four earring (gold) weight 11.88gms each. 4) Two TV, two refrigerator, two washing machine, one oven, one chimney, 7(seven) almira along with cloths and utensils, one VIP sofa set, two wooden sofa set, 6 (sex) Beds along with mattress and blanket, 2(two) gas stove with cylinder and 3 (three) empty gas cylinders etc.5) Cash amount of Rs. 4,50,000/- (Four lakh fifty thousand). The total approximate value of my lost property is around Rs. 80,00,000 /- (Eighty Lakhs).

In the above facts and circumstances, I, therefore respectfully request to your office to cause the arrest of the miscreants who belongs to the Kuki community involved in the Arson of my properties for the interest of justice. I was delay in reporting as I was engage in evacuating my family to the safest Relief Camp.

It is therefore, I requested you to kindly take up necessary legal action against the accused persons.





Sir,

I the undersigned had lodge on the above FIR no. on 03/05/2023 , in which my Two Pukka Building were arson by unknown persons belonging to Kuki Community.

After the incident on 03/05/2023 , it has been 4(four) month and found that the structured of my Two Pukka Building with 8(eight) rooms and 3(three) rooms respectively under new Patta no. 197/2523 of revenue village no. 3816/5414, 5413/5673 measuring 00.09 acre. were DEMOLISH, WIPE OUT by the unknown persons belonging to Kuki Community. The cost value for construction of the two pukka building were approximately i) 90,000,00 (Ninety Lakhs) and ii) 50,000,00(Fifty Lakhs) totally Rs 1,40,000,00(One Crore Forty Lakhs).

In the above facts and circumstances , I therefore , respectively request to Add the lost value of the Two Building which is DEMOLISH, WIPE OUT by unknown persons belonging to Kuki Community.

Now, the total approximate value of may lost property is Rs 80,000,00 ( Eighty Lakhs) + Rs 1,40,000,00 (One Crore Forty Lakhs ) = 2,20,00000 (Two Crore Twenty Lakhs).

It is therefore, I request you to Kindly Add the above lost value.
